TERMS & CONDITIONS

Under this agreement the said Stallion will be bred to the said Mare, at the agreed fee and following the terms and conditions as set out below.

SERVICE FEE

The service fee SPECIAL for the **2011** breeding season **\$500** (incl GST) paid in full by 31st August 2011.

Mare owner is responsible for the cost of collection, and transport of semen and/or breeding fees.

LFG – Live Foal Guarantee – provided with all breedings. If the mare fails to produce a live foal (a foal which stands and nurses unassisted), a breeding will be provided in the following season. The mare owner must provide proof to the satisfaction of Sienna Stud that the mare has not delivered a Live Foal and such proof must be provided within seven days of delivery by the mare. If proof is not provided within seven days the mare owner waives the right to any further entitlements under this agreement.

Should the said mare be bred to or inseminated by any other stallion after service by the said stallion, this contract is automatically voided, and Sienna Stud reserves the right to refuse to execute any papers necessary for the registration of any foal from the said mare.

Should the said mare fail to fall pregnant in the 2011/12 breeding season the full service fee price is refundable or transferable to the following breeding season.

CERTIFICATE OF SERVICE

The mare owner will be provided with an official Welsh Pony and Cob Society of Australia Service Certificate and Riding Pony Stud Book Service Certificate when the mare is certified in foal and the money owing to the Stud for service is paid in full.

I have read and understand the terms and conditions as set out in this contract. This contract must be sign and returned to the stud prior to breeding.

The Mare Owner is required to fill in description attached and supply Sienna Stud with a copy of current registration certificate, and any other information relating to the mare.

The terms of this agreement may only be modified in writing by mutual agreements between Sienna Stud and the mare owner.

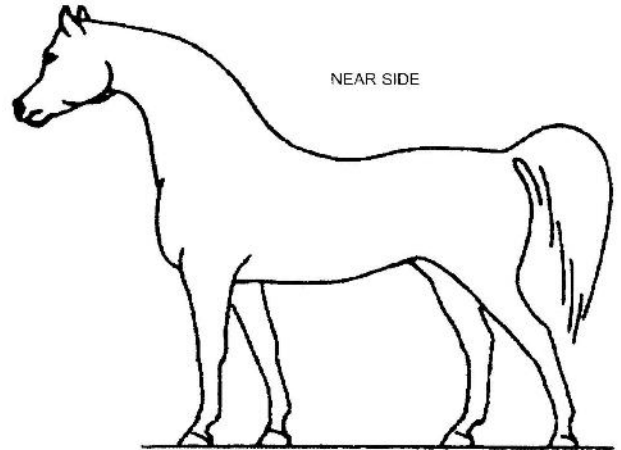

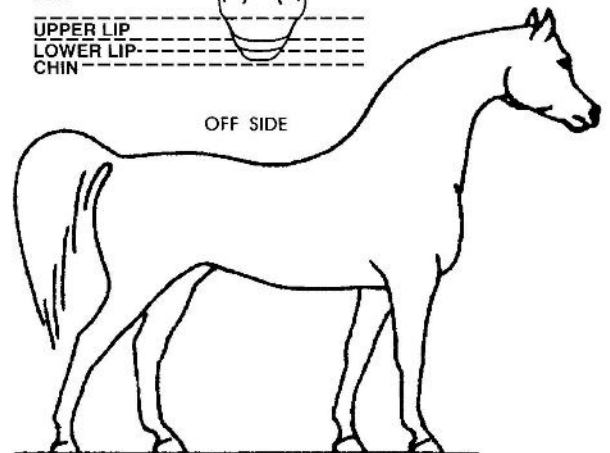
